
Subject: Grant of Permanent affiliation to nine newly established Govt. Degree Colleges in Kashmir division.


Sir,

Pursuant to the report of the Inspection Committee dated Sep. 8, 2020 and in anticipation of the approval of the competent body, the Vice Chancellor has authorized the:

Grant of affiliation in favour of Govt. Degree College, Gurez for introduction of Science Stream (B.Sc Medical & Non-Medical with an approved intake of 60 seats each) from the academic session 2021-2022, subject to the fulfillment of the following conditions, otherwise the University is vested with the authority to withdraw the same as per the relevant section of the Kashmir & Jammu Universities Act 1969 and statutes:-

1. Seek the recruitment of the necessary faculty for these programmes/courses before the commencement of the classwork;
2. upgrade the library with at least 1000 books, or 100 books on each subject, whichever is more, of the proposed programmes to include both text books and reference books. Besides two journals per subject, along with a book bank facility for students belonging to the Schedule Castes, Schedule Tribes/Minorities and such other sections as may be specified by the UGC from time to time;
3. seek the recruitment of the necessary supporting non-teaching staff from the Govt. Higher education Dept.;
4. maintain attendance of the students subject-wise/month-wise and display it in respect of the concerned students on the College notice board for the information of the students (month-wise);
5. create basic facilities like Water/Canteen/Hostel/transport/washrooms genderwise for the students;
6. develop and maintain the College landscape/playing field and fence the boundary walls of the College premises;
7. mobilise the resources of the College for attracting more students for admission purpose;
8. Adhere strictly CBSC Scheme for study purpose and semester exam of the students.
9. pay the affiliation fee as prescribed by the affiliating University.
